Conditions of Enrolment

These are the current conditions of enrolment at International Football School. In the event that an offer of a place is made to the child, parents must agree to conditions to accept the place for the child (agreement is made by selecting yes on the online enrolment application form upon submission of the form). The conditions may change by the time the offer of a place is made.

1. We agree to abide by the school's policies, guidelines and rules. These policies, guidelines and rules cover areas such as appropriate behaviour, conduct within the school and outside of the school and they may change without notice. These policies, guidelines and rules have been decided upon by the school Board of Directors and it is the principal who will publish updates at his or her discretion.
2. We agree to support the school's ethos and agree to work with the school to support our child in working towards the schools aims and aspirations. We agree to first discuss any concerns with the school and agree not to undermine the schools authority over our children.
3. We agree that the school may discipline students for breaches of the schools polices, rules or guidelines. The principal and or staff at the school may at their discretion enforce their discipline process which may include suspension or expulsion. Students will be afforded procedural fairness in all instances, including the right to be heard. If the Board of Directors, the principal or technical director feel that the relationship between the school and the parents has deteriorated to a point where says relationship untenable the school may require the removal of the student. No refund of fees will apply.
4. We agree that the school has a responsibility to provide a safe environment to enrolled children. We agree to this end that the school has permission to search a child's property which may include their school bag, electronic devices and other personal property the child may have brought to school.
5. We understand that the school's intention is to provide for a child to develop and progress in regards to their academic and footballing pursuits. To this end we agree that if the principal, at his or her discretion, believes that the student has failed to progress satisfactorily that we may be asked to remove a child from the school.
6. We confirm and agree to pay all fees due to the school on or before their due date as per the fee schedule at the time of enrolment. We also agree that the fee schedule may be changed at times. A terms notices will be given in regards to these changes. A current copy of the fee schedule can be found on the school website which will form the basis of all fees due.
7. We agree that if fees are not paid by the due date that the school may charge an administration fee at their discretion. We agree that if our account is more than four weeks over due that the school may engage the services of a debt collection agency. In this event we agree to pay all associated costs.

8. We agree that if fees are not settled by the end of a given term that the student may not enter school for the next school term. We agree that if this was to occur that the students enrolment in the school may be terminated.

9. We agree that we will give the school a full terms notice if we wish to remove our child from the school. We also agree that if less notice is given that we will be liable for the full terms fees. We understand that we are not eligible for any refunds or discounts if our child is sick, is away for unexplained reasons, is on extended leave or has been suspended.

10. We understand that it is our responsibility to inform the school if our child is not present at school each school day. We agree to inform the school in writing or via electronic means of their absence and agree that if a student is absent from school it is for extraordinary reasons and permission for extended leave will require confirmation with the Principal prior to the extended absence.

11. We agree that the school may determine the compulsory nature of activities at the school. Activities such as school camps, school excursions, school performances and other activities are compulsory and we support the school in ensuring our child participates in these events. We understand this may mean at times that the student will be required to attend events on weekends or on week nights.

12. We agree to inform the school of any medical, physiological or learning issues that our child has that may interfere with their ability to participate fully at school. We agree to forward to the school any reports or information from other professional that may help the school in supporting our child. We understand that the school may suggest at times that we seek external support and agree to consider this suggestions at our own cost.

13. We understand and agree that if we need to contact our child during the school day we will contact the school office and will not enter the school grounds without permission. We agree if we need to remove our child during the school day that we will go to the school office to seek permission to remove them.

14. We agree that the school will not hold our enrolment place indefinitely. We understand that if an offer of enrolment is made to us that we will acknowledge this offer within 30 days. We understand that if we fail to do so the enrolment position may be offered to another student.

15. We understand and agree that the school has our permission to collect personal information about the student and their families to assist the school in providing the most appropriate education. We understand and agree that the school may pass on some of this information to government bodies at times as required by the relevant authorities. We agree that the school has an obligation to report any suspicions of abuse and has not obligation to inform parents or guardians that a report has been made.

16. We agree that the school may use appropriate images or video footage of our child on the school website or other publications, in either printed or electronic form to market the school. We understand that the school will not intentionally identify our child (by the publishing of their full name) in publicly available forums.

17. We agree that the School may change the terms of enrolment from time to time. We agree that any changes made to the enrolment conditions must be given with at least one terms notice and that the new conditions will be established at the beginning of the new calendar year.

18. We understand that our acceptance of the enrolment conditions implies that our child will be enrolled at the school for the remainder of their school life. As stated in point 9 if we choose to remove our child due to unforeseen circumstances we will give notice of one full term. For example if we intended to remove our child from the school in the next calendar year we would give notice prior to the start of term four in the previous year.
